The DNI ICD 503 became effective on September 15, 2008. Any new Information System placed into service after September 15, 2008, will need to be Certified and Accredited (C&A) in accordance with the National Institutes of Standards and Technology (NIST) and the Committee on National Security Systems (CNSS) Standards, Policies and Guidelines.

This DNI ICD 503 will now enable the U.S. Federal Government, DoD and IC Agencies to all use a common set of Security Controls for Information Systems, based on NIST Regulations. Supplemental guidance for DoD and IC Agencies will come from the CNSS. This change will better enable all U.S. Government Organizations (DOD/IC) and (Non DOD/IC) to share information and have reciprocity with each other.
